Identification of Animals in Need.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

Organization officers will monitor online shelter listings and social media sites designed to promote animals at risk of euthanasia in shelters on a daily basis. Organization maintains a link on its website where owners, who can no longer care for their animals, can obtain information, contact us directly, or submit an Owner Surrender Form to relinquish their animal to us rather than taking it to a shelter. This activity has been not been undertaken in the past as the Organization has just started and it will start in the next few months (present time) and will continue to expand in the future.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted daily and will comprise about 5% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

No funding is required for this activity and no percentage of expenses is allocated to this activity.

F. How does the activity further your exempt purposes?

By providing a means for owners to relinquish their animals without cost, this activity furthers the organization's exempt charitable purposes.

Transport of Animals in Need.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

Once the Board approves of an identified animal in need, taking into consideration its location, any health or behavioral issues, and available funds and space in the organization, the Animal Coordinator will arrange transport of the animal from its current location to a RAR foster home, veterinarian, or temporary boarding facility. Transportation will be via ground, with the majority being via personal vehicles of volunteers. This activity has been not been undertaken in the past as the Organization has just started and it will start in the next few months (present time) and will continue to expand in the future.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted on an as needed basis and will comprise about 10% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

Fees for pulling animals from shelters will be provided for through the funds received from adoptions and fundraising efforts. All transportation will be handled by affiliates who do not seek reimbursement. About 12% of overall expenses will be allocated to this activity.

F. How does the activity further your exempt purposes?

By providing a means of transportation for owners and shelters to relinquish unwanted animals, this activity furthers the organization's exempt charitable purposes.

Recruitment of Affiliates.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

RAR exists solely on its volunteers. The Organization requires fosters, transporters, and other service volunteers to accomplish its mission. Recruitment is done by word-of-mouth, posting in online animal communities and through RAR's website where members of the public can apply electronically. All Affiliates must complete an application and are subjected to reference checks, public criminal history checks and veterinary reference checks (if applicable). This activity has been undertaken minimally in the past and present and will expand after RAR obtains a 501(c)(3) status.

D. What percentage of your total time is allocated to the activity?

This activity is conducted weekly and comprises 10% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

No funding is required for this activity and no percentage of expenses is allocated to this activity.

F. How does the activity further your exempt purposes?

By facilitating temporary homes and transportation to owners and shelters to relinquish unwanted animals, this activity furthers the organization's exempt charitable purposes.

Nurturing and Rehabilitating Animals in Need.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

This activity is undertaken by all foster volunteers under the supervision of the President and/or Vice President. The majority of all animals that will come into RAR's care have a vast array of medical and behavioral issues that are a result of being abandoned or the reason for being abandoned. These unwanted animals are comprised of, but not limited to: strays who have learned to fend for themselves;

puppy mill dogs who are extremely fearful of the human touch; abused animals who have a host of medical issues that come with age; abandoned animals who were left behind when the homeowner moved; and animals with serious medical issues who were surrendered due to the costs of veterinary care. It is the responsibility of the Board to match the right animal with the right foster who is willing and able to care and/or retrain the animals entrusted in their homes; Some Board members will often serve as foster volunteers and also care and rehabilitate the animals that come into our care. Nurturing and rehabilitating animals includes, but is not limited to, providing: a stable home where the animal will be housed indoors (or outdoors if applicable i.e. chickens, goats, horses, etc.); any and all veterinary care that is required or may be needed to bring the animal to a healthy and adoptable state (examinations, vaccinations, spay/neuter, fecal and heartworm checks, X-rays, blood work, other surgical procedures, etc.); quality food, special diets when needed, and access to fresh water at all times; monthly heartworm and flea preventative (if applicable); and a loving environment where the animal may heal from emotional issues; spending quality time with the animals to calm their fears, aggression, and anxiety; and utilizing training techniques and positive reinforcement to break the cycle in an animal's bad behavior. This activity has been not been undertaken in the past as the Organization has just started and it will start in the next few months (present time) and will continue to expand in the future.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted daily and will comprise about 30% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

Funding veterinary care and reimbursing foster volunteers for incidentals will be RAR's largest expenses. RAR will utilize low-cost spay/neuter, vaccine, and micro-chip clinics and has established discounted rates for veterinary and surgical procedures. The homeless animals that are found via online shelter groups usually have people who pledge to donate a specific amount of money to the rescue organization that is able to save the animal from euthanasia. Almost all foster volunteers will provide the food and everyday incidentals; however, RAR is prepared to reimburse those foster volunteers who cannot. Other funding will be provided for through the funds received from adoptions and fundraising efforts. About 82% of our overall expenses will be allocated to this activity.

F. How does the activity further your exempt purposes?

By facilitating temporary homes and nurturing and rehabilitating unwanted animals until a permanent home can be found, this activity furthers the organization's prevention of cruelty to animals and charitable exempt purposes.

Placing Animals in Permanent Homes.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

All animals that will be in the care of RAR will be promoted through a wide array of online forums and adoption sites and social media. All of these sites will direct an interested person to RAR's website where they can find more information on the animal, contact us, obtain a paper application, or apply online. Once an application is received, it is assigned to the Animal Coordinator or a trusted Affiliate. The adoption application is as follows: the application is reviewed; any current or previous veterinarians are contacted for a reference, personal references may be contacted; if the person is living in a rental unit, the landlord may be contacted for a reference; a public criminal history check is performed; an in-depth telephone interview is conducted with the applicant; and a home visit is conducted in which the applicant can meet and spend time with the animal. If the applicant advances through all stages of the application process. Board members vote on the information received. If approved, an adoption contract is signed, and the animal is delivered to their home for adoption. The adopter is given a 14-day return window that will allow them to return the animal for any reason whatsoever in exchange for a full refund or a more suitable animal. Senior citizens are offered a discounted adoption rate. This activity has been not been undertaken in the past as the Organization has just started and it will start in the next few months (present time) and will continue to expand in the future once 501(c)(3) status is obtained.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted as applications are received and will comprise about 25% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

No funding is required for this activity and no percentage of expenses is allocated to this activity. Volunteers perform all the work required.

F. How does the activity further your exempt purposes?

By finding permanent homes for the animals that were rescued and rehabilitated by RAR and providing a discounted adoption rate for seniors, this activity furthers the organization's prevention of cruelty to animals and charitable exempt purposes.

Database Management.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

An online database management system is utilized to store all information on all animals that come into RAR's care, including medical records, intake, and adoption information; stores all contact information and signed contracts for all Affiliates; stores all contact information, adoption applications, reference checks, and money collected from Adopters; houses contact information and money collected from Donators; promotes available animals on various adoption websites, etc. This

activity has been not been undertaken in the past as the Organization has just started and it will start in the next few months (present time) and will continue to expand in the future once 501(c)(3) status is obtained.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted daily and will comprise about 10% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

The funding required for this activity will be \$1 per animal adoption and purchased from Pawlytics.com. Funding is provided through adoption donations and fundraising efforts. About 5% of our overall expenses will be allocated to this activity.

F. How does the activity further your exempt purposes?

By maintaining a database that stores all related animal, volunteer, applicant, and donor activities and which also automatically pushes available animals out to online adoption sites, this activity furthers the organization's prevention of cruelty to animals, educational, and charitable exempt purposes.

Educating the Public.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

Reborn Animal Rescue believes that Rescue work and Education go hand in hand. RAR will educate the general public & media outlets on how to be responsible animal owners. This may include the importance of proper care, medical conditions that various animals may be prone to develop, working with behavioral issues, and spaying and neutering to reduce the population of homeless animals. This activity has been not been undertaken in the past as the Organization has just started and it will start in the next few months (present time) and will continue to expand in the future once 501(c)(3) status is obtained.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted weekly and will comprise about 5% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

There is no funding required for this activity and no percentage of overall expenses will be allocated to this activity.

F. How does the activity further your exempt purposes?

By maintaining a website where the public may obtain information, at no cost, on how to properly care for various animals, address behavior issues, and promoting the importance of spay/neuter procedures, this activity furthers the organization's prevention of cruelty to animals, educational, and charitable exempt purposes.

Fundraising Activities.

B. Who Conducts the Activity? AND C. Where is the activity conducted?

RAR will derive most of its funding through donations from the public. Donors learn of RAR's activities and ways to help through online animal discussion forums, through word-of-mouth, and by visiting the organization's website and Facebook page. Receipts are provided to anyone who contributes to RAR's exempt purposes, and all transactions are stored accordingly. Donations can be made in the form of cash, check, PayPal transfers and directly to a veterinary office. The sale of items with RAR's logo will also take place in the future to support RAR's exempt purposes. Donations began to be accepted in April 2020 and all other activities will increase once RAR obtains a 501(c)(3) status.

D. What percentage of your total time is allocated to the activity?

This activity will be conducted weekly and will comprise about 5% of RAR's time.

E. How is the activity funded and what percentage of your overall expenses is allocated to this activity?

The funding needed for this activity will be minimal and will come from donations resulting from various fundraising activities. Any items purchased with RAR's logo would be reimbursed by the sale of the goods. Less than 1% of our overall expenses will be allocated to this activity.

F. How does the activity further your exempt purposes?

By conducting fundraising activities to support RAR's existence, this activity furthers all of the organization's exempt purposes.

16. Check any of the following fundraising activities that you will undertake.

Small Scale Fundraising Events. We may hold small-scale fundraising efforts during such times as adoption and pet awareness events. The work performed for such events shall be "Volunteer Labor" and without compensation. The material used for such events shall only come from the gifts or contributed products. Volunteer charity lemonade or bake sales would be an example.

Online Charity Auctions. We will also, from time to time, host online auctions. All auction items will be from the gifts or contributed merchandise and all the work performed for such events shall be volunteer labor and without compensation.

Sale of Merchandise. We will have shirts, hats, mugs, and similar items available through our website in the future which will bear our logo and cause. We are only considering the sale of donated and contributed products at this time. The revenue from this activity is anticipated to be insubstantial and we have no current arrangement or contract for this.
